
NOTICE OF INTENT TO SEEK SUPERVISORY WRIT

Please take notice that plaintiff, New Orleans Regional Physician Hospital Organization, Inc. d/b/a Peoples Health Network ("PHN"), intends to apply to the Court of Appeal, First Circuit, for a supervisory writ to review this Court's judgment rendered in open court on March 30, 2015, and reduced to writing on April 14, 2015, sustaining the defendant's declinatory exception of improper venue and transferring this action to the 34th Judicial District Court, Parish of St. Bernard.

According to La. Ct. App. Unif. R. 4-3, a judge given notice of a party's intent to seek a supervisory is to set a return date by which the writ application is to be filed in the Court of Appeal. In civil cases, the return date should be no more than 30 days from notice of judgment. The notice of the April 14 judgment is dated April 17, 2015. Since May 17, 2015 falls on a Sunday, PHN requests a return date of Monday, May 18, 2015 by which it is to file its writ application in the Court of Appeal.
