NOTICE OF INTENT TO SEEK SUPERVISORY WRIT**

Please take notice that defendant, Greater Ouachita Water Company ("GOWC"), intends to apply to the Court of Appeal, Second Circuit, for a supervisory writ to review the judgment of this Court signed March 13, 2014, denying GOWC's exception of lack of subject-matter jurisdiction. GOWC gives this notice under Rule 4-2, Unif. R. La. Cts. App.

Rule 4-3 requires the Court to set a reasonable return date by which the application is to be filed. 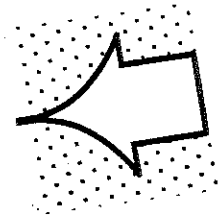
